\$2,131.73 was disbursed in 2019 for the following requests approved by the Endowment Committee in November 2018 and October 2019: (1) \$1,000 to apply to the remaining balance of the bill for repair of the church organ; (2) \$199.99 for the purchase of QuickBooks software to enable more accounting/bookkeeping to be done without the assistance of paid outside accountants/bookkeepers; (3) \$681.74 for the purchase of a laptop computer for the church office to replace the current computer purchased in 2011 and for a needed software calendar program; and (4) \$250 requested by Claudette Harring toward Immanuel's commitment of funds to defray expenses associated with presentations in Wausau and at Immanuel by Churches for Middle East Peace.

In October 2019, the Endowment Committee also approved a request from Linda Hulstrom for \$500 towards the costs of a fundraising event for a scholarship fund for youth to attend Crossways Camp in future years. The Committee noted that in the future it would prefer to entertain requests for direct scholarship funds rather than for expenses associated with holding a fundraising event, subject to the type and number of requests submitted and amounts available in any particular year.
